

Terms of access granting to training program "Reboot of Your Trading"

1. These Terms of access granting to training program "Reboot of Your Trading" by (hereinafter referred to as the "Terms") are prepared and approved by Gerchik & Co Ltd. (hereinafter referred to as the "Company") for the provision of the corresponding service for the Company's customers who wanted to get access to the training program "Reboot of Your Trading" by Gerchik (hereinafter referred to as the "Programm").
2. The Company shall provide an access to the complete Program (11 module lessons) to its Customers who refilled their clients' accounts at the Company beginning from 04.07.2019 inclusively by one or more transactions for a total amount of 1000 US dollars, as well as submitted the corresponding application to the Company using foreseen form or to personal manager.
3. The Company shall provide an access to the basic version of the Program (5 module lessons) to its Customers who refilled their clients' accounts at the Company beginning from 04.07.2019 inclusively by one or more transactions for a total amount of 999 US dollars, as well as submitted the corresponding application to the Company using foreseen form or to personal manager.
4. The deposit amount made by the Client subject to c.2 and 3 hereof may be used by the Client without any restrictions for implementation of trading and/or investment transactions under the Client Agreement.
5. In event of obtaining access to the basic version of the Program subject to c. 3 followed by depositing for a total amount corresponding to the requirements of c. 2 hereof, the Company shall provide an access to the full version of the Program to such Clients.
6. To keep an access to any versions of the Program listed in c. 2 and 3 hereof, for a time of Program studying the Client must not withdraw the amount of the deposit made under the abovementioned terms with the exception of profit derived from trading and / or investment operations. Otherwise, the Company shall have the right to restrict client access to the Program.
7. The Client shall not be entitled to transfer access to the Program to third parties, as well as copy the methodology of the Program and / or distribute the Program in own name. In case of violation of this condition, the Company shall have the right to recover from the Client the damage caused by such actions, the amount of which is determined by the Company unilaterally.
8. The Company shall have the right to make any changes and / or amendments to these Terms at its sole discretion. Such changes and / or amendments take effect from the moment they are published as an updated version of these Terms.
9. The Company shall have the right to restrict access to the Program in case of violation by the Client of these Terms and / or other incorrect actions on his/her part during the Program studying. If such a decision is accepted, the Company shall be excused from notifying the Client and explanation of the reasons resulting in such decision.
